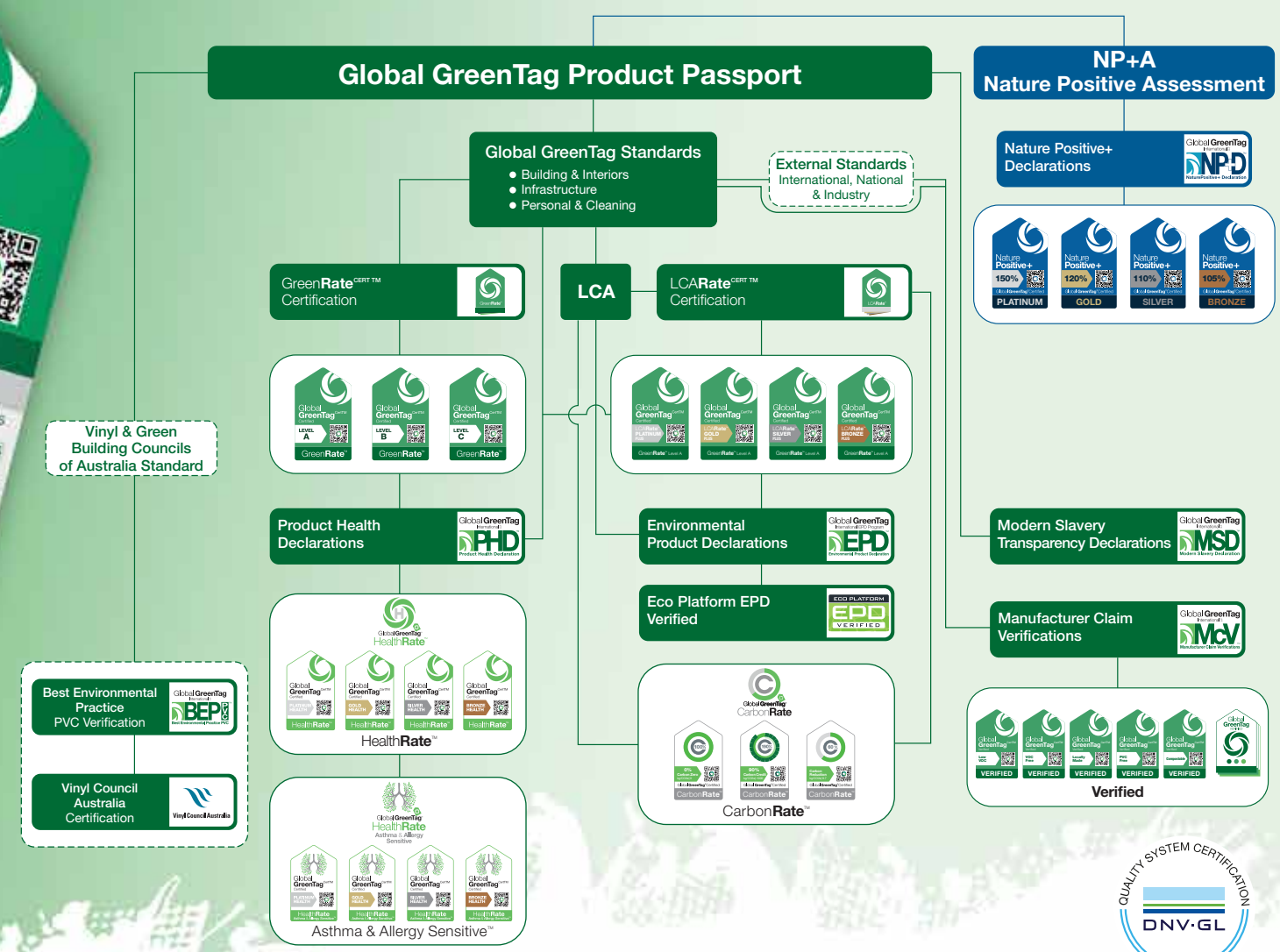

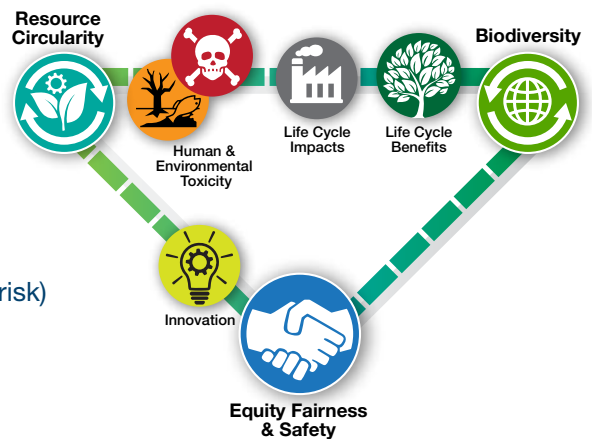

This is then followed by a review of the 'Nature based Solution' credits purchased to offset any residual unavoidable manufacturing impacts. Once it is determined that the product is making a net-positive or 'Nature Positive' contribution to the planetary system, then the full NP+D Transparency Report and its inherent Certification is issued.

Prerequisites: Proven Fitness-for-purpose, Greenwash-free marketing, and banned ingredient free content.
