- 4. Preferably accredited or certified by a recognised institution or have a record of publications, presentations, or participation in peer-reviews in the LCA field
- 5. Proficiency in type III EPD programs, particularly the rules of the EPD Program they are involved with, including the ECO Platform regulations.
- 6. In-depth knowledge of processes and products within the specific product category.

For Industry representatives:

- 1. Individuals who possess extensive industry experience or one who has a degree in the relevant discipline.
- 2. Familiarity with LCA and environmental aspects related to products.
